The list of qualified candidates of NEET-MDS 2020 which has been provided by National Board of Examination (NBE) / Health Department, Govt. of Bihar for admission to first year of the Post Graduate Private Dental Colleges of Bihar State is already uploaded on Board's website : bceceboard.bihar.gov.in .

2. **MOP UP Counselling will be conducted Off-line.**

3. In continuation to earlier published all concerned advertisement of PGMAC-2020, this is to inform all qualified, eligible and interested NEET-MDS 2020 candidates who have not duly filled the online application for PGMAC-2020 vide Adv.No.-BCECEB(PGMAC)-2020/01 & 2020/02 dated 17.04.2020 and 2020/05 dated 11.07.2020 due to any reason and not admitted in any Govt./ Private institution of India and want to attend MOP UP counselling for Dental Course can do fresh registration and submit online application form through visiting the link "**Online Application Portal of PGMAC-2020**" and by clicking "**Apply Online**" button from Board's website bceceboard.bihar.gov.in for appearing in the Mop Up round of Post Graduate Medical Admission Counselling (PGMAC)-2020 **in order to select candidates for admission against vacant state quota seats in the FIRST YEAR** of MDS Course in Private Dental Colleges viz. Mithila Minority Dental College & Hospital, Darbhanga, Buddha Institute of Dental Science & Hospital, Kankarbagh, Patna for the session 2020.

Note : There is no vacant seat in Govt. Dental College viz. Patna Dental College, Patna.

The available vacant seat position will be uploaded on the Board's website bceceboard.bihar.gov.in on the day of start of counselling.

4. The detailed procedure / instructions for registration and submission of online application form can be obtained from the Adv. No.-BCECEB(PGMAC)-2020/02 Dated 17.04.2020 uploaded on the Board's website.

5. Eligibility criteria for counselling, Fee and Fee payment procedure, instructions and other details are available in the Upgraded Revised Prospectus of PGMAC-2020 and the related Advertisement No. BCECEB(PGMAC)-2020/01 & 2020/02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 which can be downloaded from the Board's website bceceboard.bihar.gov.in .

6. Those eligible and qualified NEET(MDS)-2020 candidates who have already duly submitted Online application form in response to Advertisement no. BCECEB(PGMAC)-2020/01 & 2020/02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 respectively and whose name and PGMAC-ID is already included in the merit list published on Board's website and is not admitted in any Dental College in India need not to apply again.

Such candidates have to give their willingness for attending Mop up counselling as per programme given below by clicking the link "**Online Application Portal of PGMAC-2020**" and "**Apply Online**" button and login to account by entering registered email ID and Password by clicking "**Sign In**" button. After successful login, Click on "**Willingness for Dental Mop-up Counselling**" button and fill the required informations as asked on the screen. Click on "**Save**" button. Candidates are also advised to download or take a print out of filled application for further use.

7. Qualified, eligible & interested NEET(MDS)-2020 candidates who are eligible for granting weightage marks as per DCI regulation for work experience for working in remote / difficult area notified by Health Deptt., Govt. of Bihar vide Notification no. सं.सं.- 2/कोट-59/13-1037(2)/Health dt. 27.08.2013 and is in service of Bihar Government / Public Authority and have not filled online application for PGMAC-2020 earlier, are also being given a chance to fill the Online Application form for PGMAC-2020 as per procedure given in para-4 and the programme given below.

8. Such qualified and eligible NEET(MDS)-2020 candidates who have duly filled the online application form of PGMAC-2020 against Adv. no. BCECEB(PGMAC)-2020/01 and 02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 and have given the willingness for attending Mop up Counselling and claimed reservation for serving as Medical officer in Remote / Difficult area as "**Yes**" or "**No**" can edit their remote serving related data as per programme given below by clicking the link "**Online Application Portal of PGMAC-2020**" and click "**Apply Online**" button and login to account by entering registered email ID and Password by clicking "**Sign In**" button. After successful login, click on "**Application for M.O. Employed Candidates**" button and fill the

required informations as asked on the screen and upload the required experience certificate (**See Annexure-3A of PGMAC-2020 Updated Revised Prospectus**). Click on "**Save**" button. Candidates are also advised to download or take a print out of filled application for further use. If any candidate fails to upload the remote area working experience certificate, he/she will not be considered for incentive marks as per DCI Rules for remote/difficult area. For more details kindly refer to Adv.No.BCECEB(PGMAC)-2020/05 Dated 11.07.2020 uploaded on Board's website.

9. Candidate will have to produce his/her original certificate at the entrance gate of Counselling Hall and during the time of document verification / seat allotment process for Mop-Up counselling, otherwise he / she will not be considered for counselling.

- (iv) Willingness for attending MOP UP counselling from such candidates who have duly filled online application form for 1st round counselling : **10.08.2020 to 12.08.2020** (11.59 PM)
- v. Online Editing of Application Form (Fresh candidate) : **13.08.2020**
- vi. Online Editing of Remote data from such candidates who have filled online application form earlier vide Adv. no. BCECEB(PGMAC)-2020/01 & 2020/02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 and given their willingness for attending Mop up Counselling : **13.08.2020**
- (vii) Publication of Merit list / Rank Card : **16.08.2020** (8.00 PM)

11. The candidates participating in the counselling are directed to come prepared to stay till next day of the scheduled date of counselling.

The candidates desirous of opting seats in any Private Dental Colleges, he has to deposit a bank draft of Rs. 1,00,000/- (One lakh) only in the name of Controller of Examination, BCECE Board payable at Patna. If the candidate doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission, he/she has to deposit the rest amount of required fee to the concerned institution within 3 days from the date of his / her seat allotment / counselling.
